Participation in case review to: communicate and discuss the unique needs of the child and family and associated support services planning; ensure the seamless coordination of services; and, ensure the child and family's concerns are heard and addressed, j.

This means a preceptorship with an experienced provider in a clinical setting where the SANE can demonstrate competency in performing exams. (see Appendix 2 or IAFN guidelines).
